Annual Meeting Minutes – December 9, 2017

Call to order: 12:35 p.m.

Present: See attached list It was determined that a quorum was present.

President, Cindy Hoover, called the meeting to order, welcomed members, and introduced current Foundation Board officers.

Investments Update

Cindy introduced Eric Rowe, of Edward Jones Investments. Mr. Rowe provided an update on the Foundation's investments, stating that the Board began an investment strategy in November, 2016 with an initial investment of \$40,000. The Board added \$25,000 in 2017, and to date the investment balance has grown to \$70,401.00.

The investment strategy is conservative, using ETF's and Mutual Funds. Sixty-five percent are fixed and the balance is equity (growth and income). His management fee is less than 1% of the balance per year.

Mr. Rowe answered questions after his presentation, and left the room.

Cindy introduced Foundation committee chairs and thanked them for their service this year.

2017 and 2018 Goals

Cindy provided a review of 2017 Goals, with an update on our progress toward accomplishment of the goals. She then provided a list of proposed 2018 goals.

Motion was made, seconded, and carried to approve the 2018 goals as presented.

Budget

Vice President, Bev Bartlett, presented the proposed Foundation Budget for 2018.

Following discussion, motion to approve the budget as presented was made by Dawn Cutler, seconded by Pauline Feuling, and carried.

Election of Officers

Charley Barron, President-elect, thanked the retiring Foundation officers, Bev Bartlett, Vice President, Sandy Atkinson, State Representative, and Candace Jacobs, Member-at-Large. Charley presented the nominees as follow:

Charley explained that the Board is in the process of reviewing the job description for the State Representative, so no election will be held at this time for that position.
